**Purpose.** This document collates events material to the investigation into the death of Tilly Rowe into a single sequence. Each entry is sourced to a numbered exhibit, a witness statement (MG11) or a system-generated record and may be cross-referenced accordingly. Times are reproduced **as recorded by the originating source**; where a time is estimated or derived it is prefixed **c.** (circa). This sequence is provisional and subject to revision as further material is received. Nothing herein constitutes a finding of fact.
