You do not have to say anything. But it may harm your defence if you do not mention when questioned something which you later rely on in court. Anything you do say may be given in evidence.

The caution was read at 11:04. The interviewee confirmed she understood the caution and that she had been offered free and independent legal advice. The recording was conducted on approved digital media; the master recording was sealed in the presence of the interviewee and her appropriate adult and exhibited as **RP/1**.

RECORD OF INTERVIEW

The following is a balanced record of the recorded interview. Passages in quotation marks are verbatim from the master recording **RP/1**; remaining passages are a fair summary. Tape counter (elapsed) shown for each turn.

00:00:40	DS PROWSE	Confirms those present (DS Prowse, DC Trevena, Miss Vosper, Ms Carwithen of the duty solicitor scheme, and Mrs L. Vosper as appropriate adult), the time and date, and that the interview is being recorded. Confirms Miss Vosper has had legal advice and the caution is understood.
00:03:05	DS PROWSE	"I want to ask you about Friday night, the 12th of June, up at the field you call the Stones. Just tell me about your evening."

00:03:48	MISS VOSPER	"We all met up the field about nine. People were drinking. Me and Tilly weren't talking, it was horrible, so I left early and walked home."
00:05:02	DS PROWSE	"What time did you leave the field?" MISS VOSPER: "About half ten. On my own. I was home and in bed before eleven."
00:06:25	DS PROWSE	"Did you go back up to the field at any point that night?" MISS VOSPER: "No. I told you, I went straight home."
00:08:18	DC TREVENA	"Megan, I'm showing you location data from your own Snapchat account. It puts your phone at the Stones, the field, at 23:48 that night. How do you account for that?"
00:08:55	MISS VOSPER	After a pause: "That's wrong. The map gets it wrong all the time. I was at home."
00:10:32	DC TREVENA	"It's accurate to about twelve metres. Then your location goes dark for nearly fifty minutes, and only comes back at your home address at 00:41. Why would it do that if you were in bed from eleven?" Miss Vosper looks to her solicitor.
00:11:50	SOLICITOR	Requests a short consultation with her client. Interview suspended at 11:16 and resumed at 11:29.
00:12:10	DS PROWSE	Interview resumes. "Earlier you told us you went straight home at half ten and were in bed by eleven. Your own Snapchat puts you at the field at 23:48. Do you want to change your account?" MISS VOSPER: "No comment."
00:14:05	DS PROWSE	"At ten to eleven you messaged Tilly: 'meet me at the spot, just us'. Did she come and meet you at the field?" MISS VOSPER: "No comment."
00:18:22	DC TREVENA	"Did you have any physical contact with Tilly in that field?" MISS VOSPER, after consulting her solicitor: "No comment."
00:24:50	DS PROWSE	"Is there anything you want to add or clarify before we finish?" MISS VOSPER: "No comment."

Closing - The interviewee was reminded of the caution throughout. She was informed that the master recording would be retained sealed and that she, or her legal representative, may obtain a copy on request. The interview concluded at **11:46**; total recorded duration **42 minutes**.

Significant inconsistency for case papers: The interviewee's account of leaving the field at about 22:30 and being home and in bed by 23:00 is directly contradicted by her own Snap Map location data (Exhibit OT/9), which places her handset at Stannon Field at 23:48 with a deliberate "Ghost Mode" gap across the death window, and by her Snapchat message arranging to meet the deceased at the field (Exhibit OT/8). A minor DNA component supporting her as a contributor to the grip of the recovered stone (Exhibit JT/1) is reported separately. Recommend disclosure of the working copy to CPS with this record.
